- ELIGIBILITY.** The above named student must maintain enrollment status and satisfactory academic progress at the Benjamin Franklin Institute of Technology to be eligible to participate in the Husky Card dining program. Students who are not enrolled at the college will no longer have access to the Husky Card dining program.
- NON-TRANSFERABILITY.** This agreement is between the above named student and Benjamin Franklin Institute of Technology and may not be transferred or assigned to another individual or entity.
- DURATION OF AGREEMENT.**
ACADEMIC YEAR. The terms and conditions of this agreement are for the academic year, commencing with the fall semester and ending with the termination of the spring semester. The meal plan will be billed each semester and the plan will rollover from fall to spring automatically, unless otherwise requested by the student. While dates may be subject to change, currently, the dates for the 2012 – 2013 Academic Year are:

Fall 2012 enrollment date deadline	By Friday September 14, 2012
Spring 2013 enrollment date deadline	By Tuesday February 5, 2013

- ROLL OVER.** Any monies remaining on the Husky Card at the close of the fall semester will roll over to the spring semester. Any monies left on the Husky Card at the close of the spring semester will not rollover and must be used.
- REFUNDS.** A student who officially withdraws from BFIT may be eligible for a refund in accordance with Benjamin Franklin Institute of Technology Withdrawal and Refund Policy as stated in the catalog. Any student that is dismissed from the residence hall or from the college for violation(s) of student conduct, or voluntarily leaves the residence after the fifth week of the semester will not be eligible for any reimbursement.
- LOST CARD LIABILITY.** Benjamin Franklin Institute of Technology and Northeastern University are not responsible for lost cards and any liability associated with the lost card. Lost cards should be reported immediately to the Director of Residence Life, and all efforts to replace the card will be made.
- CONDUCT.** All Benjamin Franklin students are expected to abide by and follow the rules and regulations of the Husky Card through the expectations of BFIT and Northeastern University. Students who abuse the Husky Card system will no longer be eligible to participate.
